 What is the amount that was paid on this contract last year? This is the first time this service has been publicly solicited by the University.

## 2. What is the budget for this project?

The University expects to spend approximately \$30,000 per year for this service.

- 3. Should labor be included in the cubic yard price for the mulch? Yes.
- 4. Are vendors required to do background checks on all their employees and send the results to the University?

Yes; see page 9 of the bid for events that disqualify an employee to work on the University campus. Background check results should be sent to Steve Wargo in the Housing Department after the bid has been awarded.

- 5. Vendors will be providing this service twice per year? Yes
- 6. Does the cypress mulch in each playground need to be completely replaced each time? No, vendors will need to add to the mulch to ensure that the 12" depth requirement is met. The price for the cubic yards is listed as vendors should consider in their pricing that they may have to completely replace mulch in some cases.
