1.11 WARRANTY

- A. Special Warranty: Manufacturer agrees to repair or replace components of chillers that fail in materials or workmanship within specified warranty period. Manufacturer shall include a full, no exclusions or exceptions, warranty from date of Substantial Completion.
 - 1. Extended warranty covering entire chiller, including but are not limited to, the following:
 - a. Complete chiller "bumper to bumper" including refrigerant and oil charge (100% coverage; no exclusions or exceptions).
 - b. Condenser coil.
 - c. Fans and fan motors.
 - d. Control boards, wiring, etc.
 - e. Variable frequency drives.
 - f. Complete compressor and drive assembly.
 - g. Parts and labor.
 - h. Loss of refrigerant charge for any reason.
 - 2. Warranty Period: Five (5) years from date of Substantial Completion.

1.12 ADD ALTERNATES

A. ADD Alternate No. 1: Surge Protection Devices.

- 1. Base Bid: New chiller per Section 236426.13 "Air-Cooled, Rotary-Screw Water Chillers" excluding Surge Protective Devices under Article 2.1, Paragraph P.
- 2. Alternate: In addition to Base Bid, provide Surge Protection Devices listed under Section 236426.13 "Air-Cooled, Rotary-Screw Water Chillers"; Article 2.1, Paragraph P.

B. ADD Alternate No. 2: 10-year Full Warranty.

- 1. Base Bid: Provide 5-year full warranty as outlined in Section 236426.13 "Air-Cooled, Rotary-Screw Water Chillers"; Article 1.11, Paragraph A (and associated subparagraphs).
- 2. Alternate: In addition to Base Bid, provide extended warranty for years 6-10 as outlined in Section 236426.13 "Air-Cooled, Rotary-Screw Water Chillers"; Article 1.11, Paragraph A (and associated sub-paragraphs).
