NOTICE OF BID/PROPOSALS PROTEST BONDING REQUIREMENT ANY PERSON OR ENTITY WHO FILES AN ACTION PROTESTING A DECISION OR AN INTENDED DECISION PERTAINING TO A COMPETITIVE SOLICITATION SHALL AT THE TIME OF FILING THE FORMAL PROTEST, POST WITH THE UNIVERSITY A BOND PAYABLE TO THE UNIVERSITY IN AN AMOUNT EQUAL TO: 10% OF THE ESTIMATED VALUE OF THE PROTESTOR'S BID OR PROPOSAL. 10% OF THE ESTIMATED EXPENDITURE DURING THE CONTRACT TERM. \$10,000.00 OR WHICHEVER IS LESS.
