#### **Questions and Answers**

- Q1. At the pre-bid it was mentioned that the contractor will be responsible for moving any equipment/furniture/fixtures in the rooms affected by this project. Exactly what equipment/furniture/fixtures will be the responsibility of the contractor and how will this be coordinated/handled between UF and the contractor?
  - A1. Moving of the equipment/furniture/fixtures in the rooms affected by the work will be the successful contractor's responsibility. The successful contractor will work with College of Dentistry Facilities Manager, and the room's occupants to move/relocate the equipment prior to the work beginning and replace the equipment once the work is completed. As the work is scheduled to be overnight, equipment should be moved out between 3PM and 6PM and replaced prior to 7:30AM the next morning.

An estimated list of equipment located in rooms on floors 8, 9 and 10 will be provided to the Mandatory Pre-bid attendees. Please note, this list may not be a complete list due to ongoing research.

- Q2. Will an allowance for the moving of equipment/furniture/fixtures be added as an alternate on the price page?
  - A2. The cost of the moving/replacing of equipment should be included in your base bid. An information only line item has been added to Section 00310 Bid Forms to denote the actual cost for moving/replacing of equipment. See attached, revised Section 00310 Bid Forms.
- Q3. Will the CHW system need to be up and running and insulated by the next morning?

A3. Yes.

- Q4. The bid specifications call for solder joints 3" and below. Can we use pro-press in lieu of solder?
  - A4. No. Pressed piping fittings do not comply with UF Design and Construction Standards dated June 2019.
- Q5. All rooms are locked. Will keys be provided to the contractor?
  - A5. Keys will be provided to the successful contractor by UF HSC Facilities Services.
- Q6. Was it intentional to not include 10<sup>th</sup> Floor South? During the walk through it was discovered that there was only a short section of the main on 10<sup>th</sup> floor south that was replaced. The Fan coil units, etc. still needed to be replaced?
  - A6. Bid the project as specified. The drawings show the complete scope of work for the project as the 10<sup>th</sup> Floor south is not in the scope of work.
