Questions and Answers

- Q1. What are UF's insurance requirements?
 - A1. See Article 19 of the General Terms and Conditions. A link to General Terms and Conditions can be found In the Non-Technical Specifications Table of Contents (page 5 of the Bid Document).
- Q2. Is there a 100% payment and performance bond required for this project?
 - A2. Yes. See Article 20 of the General Terms and Conditions. A link to General Terms and Conditions can be found in the Non-Technical Specifications Table of Contents (page 5 of the Bid Document).
- Q3. Is the cost for performance and payment bond to be included in the base price?
 - A3. Yes.
- Q4. Is a Bid Bond required?
 - A4. No.
- Q5. What is the budget for the project, each lot?
 - A5. Lot 1 (Basic Science) \$475,000 Lot 2 (Communicore) - \$500,000
- Q6. Where will the contractor have access for a crane for Elevator #25 in Basic Science?
 - A6. The crane can be set up at the UF Health (Shands) loading dock but this will need to be coordinated with the dock manager and will need to be done on a Saturday to avoid heavy traffic.
- Q7. Are the elevator interior finishes in the spec? If not, what is the spec?
 - A7. Provide and install cab finish materials as described in Part 2.06 of Specification Section 14 24 24. As part of the submittal review process, submit product data with a description for each finish material specified in Part 2.06. As part of the elevator submittal package, include either physical samples or a printed color chart where color selections for finishes are involved. Electronic color charts will not be accepted. The Architect shall select finish colors, where applicable, based on the submitted sample or chart.
- Q8. Part 1.04 of the spec reads that Related Work by Others is the responsibility of the GC. Please confirm: Is the GC is submitting their price for this work directly to UF or will the bidder be responsible for including the GC price in their bid as a total turnkey project?
 - A8. Bids submitted for each lot should include all work as a turnkey project.
- Q9. Which building would UF prefer to begin work on first?
 - A9. Basic Science Building, Elevator #26.
