- (5) CANCELLATION Orders or contracts resulting from the bid award will be subject to immediate cancellation if either the product or the service does not comply with the bid specifications.
- (6) AVAILABILITY OF FUNDS The State of Florida's and the University's performance and obligation to pay under this contract is contingent upon an annual appropriation by the Legislature of the State of Florida.
- (7) INQUIRIES The University will not give verbal answers to inquiries regarding the specifications, or verbal instructions prior to or after the award of the bid. A verbal statement regarding same by any person shall be <u>non-binding</u>. The University is not liable for any increased costs resulting from the Bidder accepting verbal direction. All changes, if necessary, shall be made by written addendum to the bid.

- (9) DELIVERY Delivery is requested within ten (10) calendar days after receipt of purchase order.
- (10) WARRANTY The successful bidder shall furnish factory warranty on all equipment furnished against defect in material and/or workmanship. The <u>factory</u> warranty shall become effective on the date of delivery and acceptance by the University. Should any defect in material or workmanship, excepting ordinary wear and tear, appear during the above stated warranty period, the successful bidder shall repair or replace same at no cost to the University immediately upon written notice from University Procurement.
